The Indiana Department of Environmental Management's Drinking Water Branch has received information indicating your facility is connected to city water. Consequently, as of October 18, 2016, your public water system has been inactivated and is no longer required to comply with the federal and state drinking water testing requirements. Please notify our office of any status changes regarding your facility. Your facility information will remain in our files for future reference, if necessary. The unused public water supply well must be abandoned in accordance with 312 IAC 13-10-2. The Department of Natural Resources, Division of Water (317-234-1085) is to be notified in writing of a well abandonment within thirty (30) days after plugging is completed.


