ORDER ENTERING TEMPORARY STAY

The presiding Environmental Law Judge, sua sponte, **ORDERS** the entry of a temporary stay of effectiveness of the Notice and Order of the Commissioner of the Indiana Department of Environmental Management. This Order Entering Temporary Stay is issued pursuant to Ind. Code §4-21.5-3-8, I.C. §4-21.5-4 et seq. and 315 IAC 1-3-2.1 and shall take effect immediately and be in effect for sixty (60) days from date of issuance. At this time, based on both Indiana Governor Eric Holcomb and Indianapolis Mayor Joseph Hogsett's orders regarding the public health emergency and measures to be taken regarding social distancing, the ELJ, based on available information, determines that a sixty day postponement does not present a threat to human health or the environment.

The stay hearing set for May 15, 2020 is CONTINUED until July 10, 2020 at 9:00 a.m. ET to be held in Office of Environmental Adjudication, 100 North Senate Avenue, Room N103, Indianapolis Indiana.
