CLAY COUNTY (COALMONT) REGIONAL SEWER DISTRICT JUNE 2023

PETITION TO ESTABLISH A REGIONAL SEWER DISTRICT

Petitioner, Clay County, by its authorized representatives, the Board of County

Commissioners, tenders its Petition to the Commissioner of the Indiana Department of

Environmental Management (IDEM) for an order directing that a regional sewer district be

established under IC 13-26 as an independent municipal corporation in Clay County, Indiana. In

support of this Petition, Petitioner alleges:

- 1. <u>Authorization by Fiscal Body</u>. The filing of this Petition has been authorized by the County Council as required by IC 13-26-2-2. A copy of the authorizing resolution is attached to this Petition as Exhibit "A".
- Authorized Representative of Petitioner. The authorized representative for the Petitioner shall be Mr. Paul Sinders, member, Clay County Commissioners (812-251-7241; email: psinders@gmail.com).
- Principal Office. The principal office of the district shall be located at Commissioner's Office, Clay County Courthouse (609 E. National Avenue #106, Brazil, IN 47834).
- Name of District. The name of the regional sewer district shall be the Clay County (Coalmont) Regional Sewer District.
- 5. <u>District Territory Description</u>. The territory to be included in the district is entirely within Clay County and includes the territory shown in the map attached to the Petition as Exhibit "B". The territory generally includes the unincorporated community of Coalmont bounded by County Road 1300 South to the North, State Road 48 to the

South, County Road 700 West to the West, and approximately 1,500 feet east of the Indiana Rail Road along County Road 1350 South to the East.

- 6. Governmental Entities and State Property in District. The following governmental entities (political subdivisions) have territory within the proposed district boundaries: Lewis Township. The following state agencies own, control, or lease land within the proposed district: The Indiana Department of Transportation, Indiana Department of Natural Resources (Shakamak State Park) and the Indiana Rail Road Company.
- 7. <u>Current Services in District</u>. Potable water is provided in the proposed district by the City of Jasonville Water Utility. Sanitary waste is disposed of in the proposed district exclusively by on-site septic systems.
- 8. <u>Indebtedness</u>. There is no outstanding indebtedness in the district territory for the proposed purpose of the district.
- 9. Need for District. The Clay County Commissioners are under an Agreed Order with the Indiana Department of Environmental Management for untreated sewage discharges from the unincorporated community of Coalmont. Numerous on-site septic systems directly discharge to roadside ditches. The discharge of untreated sanitary sewage to any surface waters or ground waters of the state is a violation of Indiana Administrative Code. In addition, based on IDEM's inspection, many septic systems appear to be unapproved sewage disposal methods along with open sewer laterals discharging directly on the ground and into waters of the State which is a direct violation of 410 IAC 6-8.3-52 and Indiana Code (IC) 13-30-2-1. Additionally, the need for the proposed District has also been recognized by residents, businesses, and elected officials

such as the Clay County Commissioners and other members of the public. The absence of public sanitary sewer service is a public health and safety concern in addition to having a negative impact on the value of property within the proposed District.

Resolutions and letters of support for the establishment of the district from COUNTY COMMISSIONER, COUNTY HEALTH DEPARTMENT and the City of Jasonville are included with this Petition as Exhibit "C".

- 10. <u>Purpose of District</u>. The purpose of the district is to reduce the risks to public health and the environment posed by failing or inadequate septic systems through the construction of a sanitary sewer collection system and wastewater conveyance system to transport the wastewater for appropriate treatment and disposal.
- 11. Alternatives to Creating District. The primary alternative to creating the district would be that the City of Jasonville extends sewer service to the district. While the City of Jasonville has agreed to maintain the collection system and treat the wastewater from the District, the City has declined pursuing the option of financing the extension of sewer service to the district. A secondary alternative is to replace the existing on-site septic systems with new systems approved by the County Health Department; however many of the properties are not adequately sized for the required on-site systems. A preliminary engineering report (PER) was prepared by HWC Engineering which evaluated alternatives for the area with respect to wastewater collection and treatment, as noted below in Item 13.
- 12. <u>Initial Financing Plan</u>. Until the district is in receipt of revenue from its operations or proceeds from the sale of bonds, Petitioner plans to finance the cost of the operations of the District by the receipt of funds from Clay County.

- 13. Estimate of Cost/Preliminary Engineering Report (PER). Attached to this Petition as Exhibit "D" is a Preliminary Engineering Report (PER) that sets forth the basic plan for implementing the purpose of the district, including estimates of the following:
 - a. the costs of accomplishing the purpose of the district:
 - b. the costs of constructing, operating, and maintaining the facilities; and
 - c. the sources of the funding of these costs
 - d. customer rates to be determined pending financing and funding terms for the project.

A preliminary Cost of Service Study as prepared by Baker Tilly is included in the PER in Exhibit D and includes the proposed wholesale rate that will be required for operation and maintenance of the facilities.

- 14. <u>Board of Trustees Appointment Recommendation</u>. Petitioner recommends that the district board of trustees shall be made up of 3 members, appointed as follows:
 - a. Two (2) members appointed by the Clay County Commissioner's Office residing in the district, and
 - b. One (1) member appointed by the Clay County Commissioner's Office to represent the City of Jasonville.
- 15. <u>Board of Trustees Term Recommendation</u>. Petitioner recommends that the initial appointments shall be limited to the following term lengths:
 - a. Clay County Commissioners' first appointee: 3 years

- b. Clay County Commissioners' second appointee: 3 years
- c. Clay County Commissioners' Jasonville representative appointee: 3 years

 Upon vacancy due to expiration of the initial appointment term, all appointments shall be for terms of four years. Upon vacancy for any reason before the expiration of a term, the appointing authority for that Trustee shall appoint a new Trustee to complete that term within 45 days.
 - 16. <u>Notice and Public Meeting</u>. Petitioner has public noticed and conducted a public meeting as required by IC 13-26-2-2.5 before the filing of this Petition.
 - a. Public notice for the public meeting was provided by newspaper publications, radio broadcasts, and mailings according to the dates and intervals required by IC 13-26-2-2.5(b). The proofs of publication and affidavits of newspaper publications and radio broadcasts are attached hereto as Exhibit "E".
 - b. The public meeting was conducted on May 31, 2023. The information discussed at the public meeting, a sign-in sheet of attendees, and a list of the questions received at the meeting are included in Exhibit "F."
 - 17. Petition Filing and Availability. This Petition has been filed with all parties required by IC 13-26. This Petition has been filed within the time limits required under IC 13-26-2-2.5(d). Copies of this Petition and any subsequent amendments are available for review for 180 days from the date of filing with IDEM at the Clay County Commissioner's Office.

WHEREFORE, Petitioner requests:

 That IDEM public notice and conduct a public hearing on this Petition under IC 13-26-2; and That the IDEM Commissioner grant the relief requested in this Petition by issuing an order establishing the Clay County Regional Sewer District.

This Petition for an order to establish a sewer district is respectfully submitted to IDEM on June 29, 2023. As the authorized representative of Petitioner, I swear or affirm that the statements and representations in this Petition are true, accurate, and complete to the best of my knowledge.



Notice of Public Hearing Coalmont, Clay County Intent to File a Petition to Form a Regional Sewer District

Notice is hereby given to property owners of Clay County, Indiana that the Clay County Board of Commissioners will hold a public hearing to consider filing a Petition with the Indiana Department of Environmental Management (IDEM) seeking authority to establish a Regional Sewer District (RSD). The primary purpose of the RSD is to address an Agreed Order issued by IDEM for discharge of untreated and unpermitted wastewater directly to waters of the state in areas within the boundaries of the proposed district.


The meeting will be at 7:00p.m. on Wednesday, May 31, 2023, at the Lewis Township Fire Department, 6440 W. Public Road, Coalmont, Indiana 47845.

The proposed regional sewer district will generally encompass an area of Lewis Township including the unincorporated community of Coalmont and extending south/southeast (south of CR 1400 S) along State Road 48 on the west end and the Indiana Rail Road corridor on the east end to the Clay County southern and eastern boundaries. A map of the proposed district will be available for viewing at the meeting and on file with the County Commissioners.

Preliminary recommended wastewater improvements as described in a completed Preliminary Engineering Report (PER) will be presented. The recommended improvements include a proposed low pressure sewer system with individual grinder pumps for wastewater collection in the immediate Coalmont area and regionalization with the City of Jasonville for wastewater treatment via a lift station and force main.

The project is planned to be funded with a combination of loans and grants from USDA Rural Development and the Office of Community and Rural Affairs (OCRA). The completed study will be updated to meet the funding requirements and will be presented in detail at a public hearing at a later date. Sanitary sewer improvements are not planned for all areas of the proposed district.

During the public meeting, the Clay County Board of Commissioners and their engineering consultant will discuss the need for the proposed sewer district and the anticipated project to achieve compliance with the Agreed Order with IDEM. There will be the opportunity for questions and comments from the public at this meeting. Participation is welcomed and encouraged.






Regional Sewer District Boundary






Wastewater Collection System

Questions/Comments Coalmont | Clay County



After the presentation, Mr. Eric Smith opened the floor to questions from the attendees. The following is a list of the questions asked along with the responses.

- Q1 Are you required to connect to the sewer system?
- A1 A property can be exempted if it has an adequate septic system as determined in writing by the local Health Department or the department's designee. Refer to Indiana Code (IC 13-26-5-2.5) for more information.
- Q2 Who is responsible for maintaining and replacing the grinder pumps? Is it the homeowner or the District?
- A2 The District is responsible for maintenance and replacement of the grinder pumps. For operation and maintenance of the grinder pumps, the District would enter into an Interlocal Agreement with the City of Jasonville.
- Q3 Is our monthly water bill going to double?
- A3 –The sewer bills will be separate from the water. The rates will be determined based on the percentage of grant and loan funds received for the project. A financial advisor will be hired during the preliminary engineering report to prepare a rate analysis.
- Q4 When grinder pumps need replaced will there only be one pump manufacturer that can be used?
- A4 –The contractor will install the grinder pumps as part of the project, which will all be from a single manufacturer. In the future, a different pump manufacturer could be used if approved by the District.
- Q5 Does Jasonville's WWTP have capacity to treat the flows from Coalmont?
- A5 –A project is currently planned for upgrades and expansion of Jasonville's WWTP. The project will be completed prior to construction of the Coalmont sewer system. The expansion will allow Jasonville's WWTP to handle the flows from Shakamak State Park and Coalmont.
- Q6 What happens to the grinder pumps when power goes out?
- A6 The grinder pump units have some storage capacity, however, during long outages, water will need to be conserved.

- Q7 What other costs are required aside from a monthly bill?
- A7 The cost of the electrical service from the home to the grinder pump and the cost of a sewer lateral from the home to the grinder pump. It has not been determined if the cost of abandoning the septic tank will be included in the project or part of the homeowner's cost.
- Q8 Will future public meetings be held, and if so, will they be in Coalmont like this one or elsewhere?
- A8 Yes, there will be future public meetings regarding the project. It is preferable to have the meetings in Coalmont, but that will be determined by the RSD. IDEM will also conduct a separate public hearing regarding the RSD formation.
- Q9 Are homes outside of the proposed district allowed to connect to the sewer system?
- A9 This would be determined on a case by case basis depending on location of the property.
- Q10 Are the homes along SR-48 that are within the district boundary but not within the Coalmont area required to connect?
- A10 No, these homes are not required to connect since they are not within the area of violations identified by IDEM. Additionally, there is not a low-pressure sewer planned along SR-48 currently, only a proposed force main.

At this time, there were no further questions and the meeting was adjourned.
