The Hamilton County Board of Commissioners are herewith petitioning the Board of Trustees ("Trustees") for the Hamilton County Regional Utility District to expand the boundaries of the District territory. The general description of the territory ("Territory") to be added includes certain properties owned by Hamilton County through its Parks and Recreation Department outside the District's current boundary, including the following properties:

1. Strawtown Koteewi Park
2. White River Campgrounds
3. Lafayette Trace Park

The Board of Commissioners petitions the Trustees to add the Territory to the District for the following reasons:

- a) It is necessary to include the Territory in the District as it is County owned property;
- b) Inclusion of the Territory in the District will be conducive to the public health and safety in that the properties are currently served by wells and septic systems that over the course of time will need upgrading and/or replacing to meet the anticipated needs in this area; and
- c) It is practical and feasible for the Territory to be included in the District.

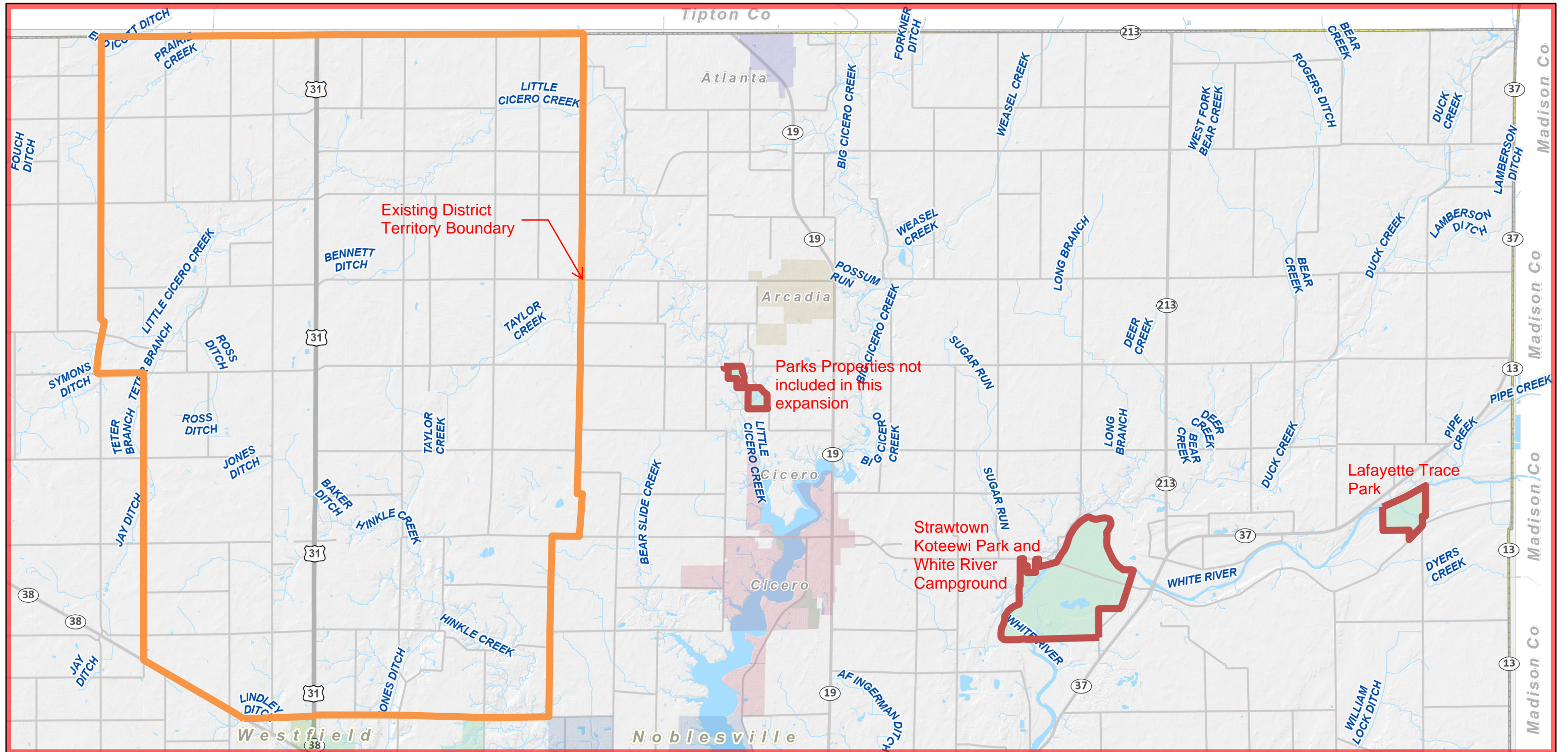

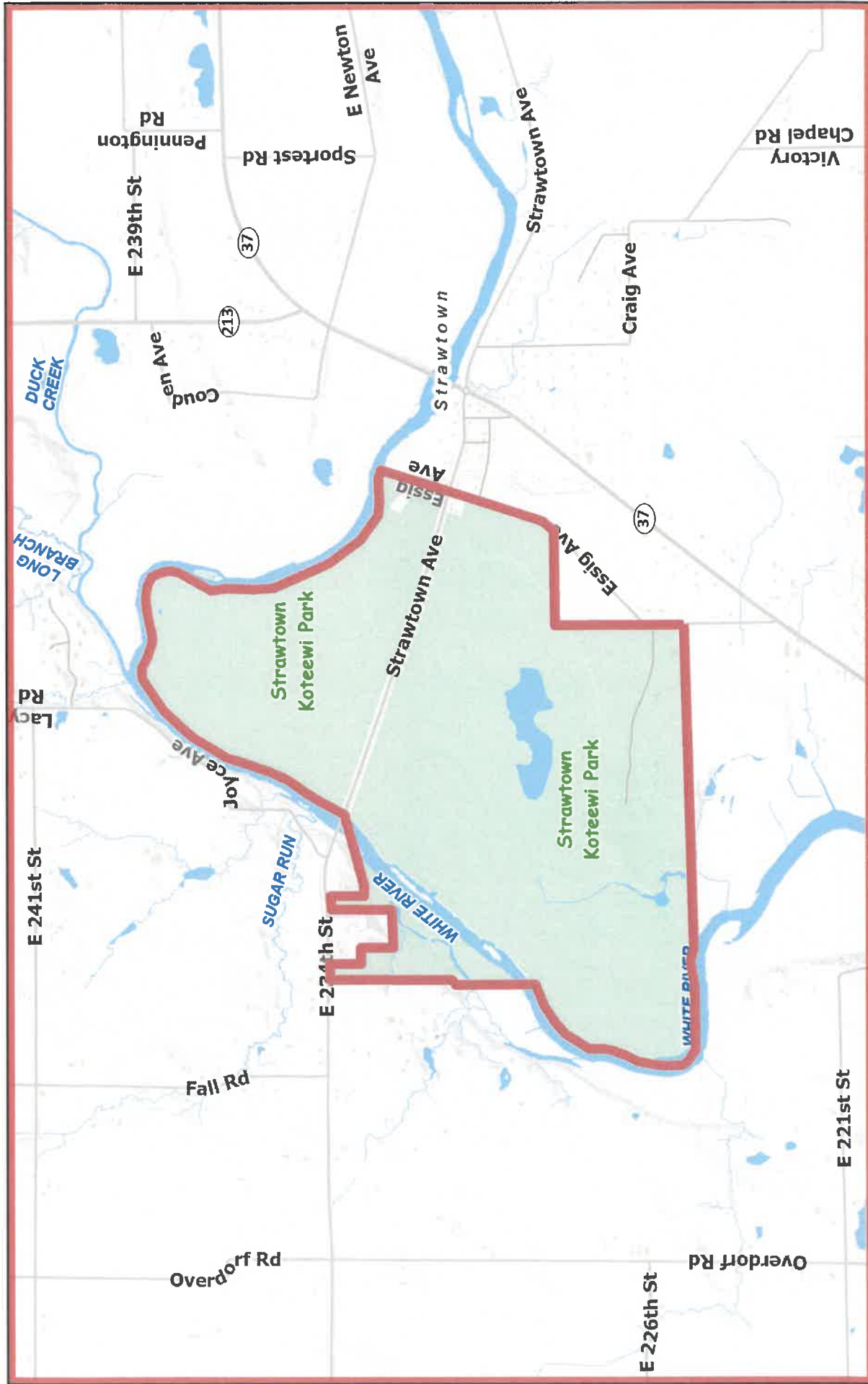

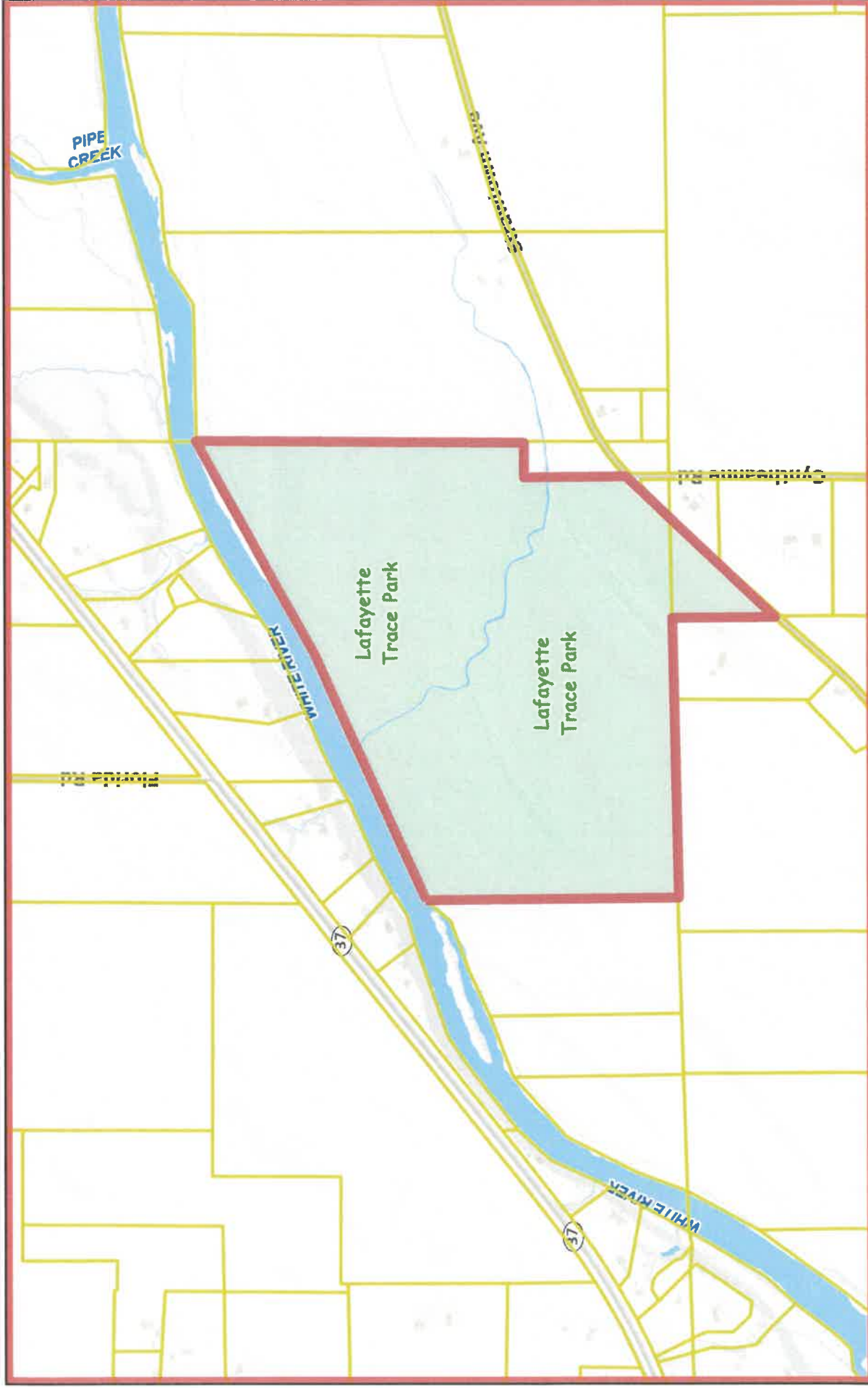

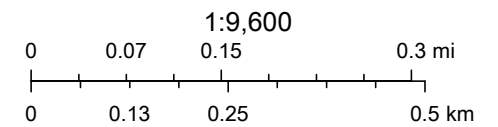
