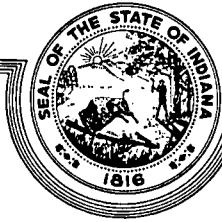

This is a public hearing before the Stream Pollution Control Board in a cause docketed before the Board as Cause No. B-436,

IN THE MATTER OF THE PETITION, FILED BY THE TURKEY CREEK TOWNSHIP TRUSTEE, KOSCIUSKO COUNTY, STATE OF INDIANA, FOR ESTABLISHMENT OF A REGIONAL SEWER DISTRICT TO BE KNOWN AS "TURKEY CREEK REGIONAL SEWER DISTRICT," PURSUANT TO IC 19-3-1.1.

Notice of time and place of hearing was given as provided by law by requesting publication on Wednesday, July 27, 1977, and Wednesday, August 3, 1977, in the Mail Journal, Syracuse, Indiana.

Proof of publication of the notice has been received by the Board and the notice and the proofs are now incorporated in the record of this cause by reference and placed in the official files of the Board.

Notice has also been given to the Hearing Commissioner and the Office of the Attorney General.

I am an attorney for the Indiana State Board of Health and have been appointed by the Stream Pollution Control Board to Act as Hearing Officer in this cause by virtue of the authority granted in IC 13-7, and by resolution adopted by the Environmental Management Board of the State of Indiana on May 9, 1972.

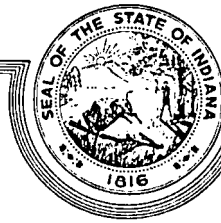

Enclosed herewith is a NOTICE OF PUBLIC HEARING concerning a petition for the organization of a regional sewer district to be known as the TURKEY CREEK REGIONAL SEWER DISTRICT, for publication in your newspaper.

Notice is hereby given that the Advisory Board of Turkey Creek Township, Kosciusko County, State of Indiana, pursuant to IC 19-3-1.1, has filed a petition with the Stream Pollution Control Board of the State of Indiana asking for the establishment of a regional sewer district to be known as the "TURKEY CREEK REGIONAL SEWER DISTRICT."

The territory to be included in the district shall include that area contiguous to Lake Wawasee, all located in Kosciusko County, Indiana, and which is more particularly described in Petitioner's Exhibit "A" on file with the Indiana Stream Pollution Control Board and the Kosciusko County Commissioners.

Notice is further given that a public hearing will be held to consider said petition on Wednesday, August 10, 1977, at 7:00 p.m., EST, at the Wawasee High School Auditorium, Syracuse, Indiana.
