## MINUTES OF MEETING BEAR LAKE, HIGH LAKE, WOLF LAKE REGIONAL SEWER DISTRICT AUGUST 3, 1995, 10 A.M.

## THOSE PRESENT:

The purpose of this meeting was to review the Bear Lake, High Lake, and Wolf Lake wastewater collection and treatment system project with the State RECD office and to assist the loan applicant in determining the best project size.

- 1. The meeting started with Steve Henschen providing a brief overview of the location and size of the proposed project. We discussed populations, wastewater flows, and demographics of the proposed sewer district.
- 2. Jim Bowser then reviewed the history of the project, taking over from Jim's involvement with the East Shore Conservancy District, the East Shore Conservancy District's violation letters with IDEM, and the proposed activities with the County Commissioners to obtain planning funds and ultimately construction funds.
- 3. It was stated that the Commissioners of Noble County and the East Shore Conservancy District had met twice with the EIWG (Environmental Infrastructure Working Group) in December of 1994 and February of 1995 to develop the best action plan for financing of a proposed project.
- 4. We discussed the project costs with the group. I indicated that the feasibility study had costs broken down into the various phases. As a key component of this feasibility study, regardless of what the other areas in the proposed regional sewer district did, the East Shore Conservancy District would have to construct some type of project to comply with the IDEM Agreed Order. The project costs discussed were as follows:

Phase I (East Shore)	\$1,300,000
Phases I and II (East Shore/North	n Shore) \$3,300,000
Phases I thru IV (Entire Project)	

5. As a result of the meeting with EIWG in February, it was determined that the best project size to pursue is the Phases I and II project for a total of \$3.3 million. Since that time, additional discussion with Bob Deal has indicated that may have been too large of a project, and the wait for those funds might exceed the applicant's needs.

- 6. The main purpose of today's meeting was to identify whether the loan and grant application should proceed with the \$3.3 million project, or would they have a better chance of obtaining funds with the \$1.3 million project. After much discussion, it was determined that the loan applicant's best chances for receiving funds in 1996 would be to pursue the \$1.3 million project for Phase I.
- 7. Joe Steele indicated that requesting funds in this smaller amount would not hurt the proposed sewer district's chances for receiving additional funds in the ensuing years.

Additional comments were made relating to RECD's funding involvement in this project. They are as follows:

- Jim Bowser indicated that approximately 70% of the dwelling units in this project area are occupied full-time. He feels that number is higher in the East Shore, possibly as high as 80%.
- Jim Bowser indicated a majority of the residents in this area are retired and on fixed incomes.
- Bob Deal and Joe Steele both discussed the fact that if treatment capacity is included for Merry Lea's facility, they may have to pay their share of the treatment costs, to not cause an undue burden on the residents of the Bear Lake area.
- Bradley Thompson stated that an environmental review should take place for the entire proposed project, rather than just the Phase I portion. Bill Spohn responded to Bradley that this is how we are already proceeding to conduct the environmental review.
- Bob Deal discussed with Joe Steele the possibility of using the feasibility study already prepared for the preliminary engineering report, even though the engineering report analyzes the entire regional sewer district. Joe Steele indicated that this is acceptable, as long as a discussion and project costs were provided for the Phase I project.
- Joe Steele said RECD would expect to receive approximately \$15 million in loan money and \$7 million in grant money from the Federal office in October, if things are similar to 1995's budget. He said that they have received a request for over \$85 million in loans and \$50 million in grant funds. Therefore, competition for these funds is very tough. He stressed the importance of completing the full application and environmental review as quickly as possible to have this project proceed.

I received a phone call from Mr. Jeff Harrell on February 1, 1996. Mr. Harrell had sent a letter to IDEM which outlined his concerns regarding the proposed regional sewer district. Jeff Feller faxed me a copy of Mr. Harrell's letter and asked me to respond to the letter. Mr. Harrell and I discussed the following items. The responses are related to the six questions in Mr. Harrell's letter.

## Response No. 1:

There has not been an environmental impact study completed in the project area. The county health department has indicated that the area is not suitable for septic systems due some of the reasons listed below:

- Many households stand on ground that was formerly lake bottom. These soil types are not suitable for septic systems
- Small lots do not allow for properly sized absorption fields
- Many absorption fields ate connected to tiles that drain to the lakes
- There is a concern for well water contamination due to the close proximity of water wells to septic systems (less than 50 feet)

## Response No. 2:

I am not aware if the County has recently tested the water quality of the lakes. I suggested that Mr. Harrell contact Jack Chronister of the Noble County Health Department.

#### Response No. 3:

The proposed sewer district will be a regional sewer district (RSD). An RSD does not have the authority to levy taxes or assessments on properties or persons. Funds are only generated through user fees typically billed each month to the user or household.

## Response No. 4:

Currently, state law requires that if your dwelling is within 300 feet of a sewer, you can be required to connect to the sewer system.

# Response No. 5:

Many landowners within the proposed sewer district signed a petition for the formation of a sewer district.

## Response No. 6:

I am not able to answer why the IDNR did not wish to use your private drive for a public access. Any proposed sewers in private drives would require an easement from the land owner. Dear Mr. Henley

OBJECTIONS TO ESTABLISHMENT OF SEWAGE DISTRICT

## INTRODUCTION

The Feasibility Study dated March, 1995, for The East Shore Conservancy District, Bear Lake, High Lake and Wolf Lake prepared by Bonar & Associates, Inc. (the "Feasibility Study") and related matters clearly fail to establish either the need for the proposed district or the economic feasibility of the proposed district. Additionally, at the present time, the proposed district has not yet been properly approved by the Noble Township Board as required by I.C. §13-3-2-3(b).

These objections are prepared on behalf of Larry Boyd, Post Office Box 272, Wolf Lake, Indiana 46796 and are joined in by the residents of Wolf Lake and surrounding area whose names, signatures, addresses and telephone numbers are attached hereto, all of whom would be adversely affected by this proposed project. It is directed at the need for including Wolf Lake and its surrounding area and does not attempt to judge the need for the establishment of a sewer district for High Lake and Bear Lake.

#### NEED FOR THE PROJECT

The Feasibility Study makes its case of the need for the District in Chapter 2 and is based almost entirely upon existing problems with the East Shore Conservancy District and soil types and housing density problems associated with High Lake and Bear Lake, with no evidence as to what relationship the problems at High Lake and Bear Lake have to Wolf Lake and its surrounding area. Almost as an afterthought, the Feasibility Study notes that shallow wells provide a basis to include the Wolf Lake area. What is remarkable though is that neither the Feasibility Study nor the Health Department Letter in support of the district (Appendix B) indicate the existence of, or problems with, any shallow wells in Wolf Lake. Moreover, there is no indication of any water quality degradation in Wolf Lake nor individual wells. In fact, Wolf Lake has no housing on it and it is up stream from Bear Lake and High Lake and thus is not contaminated by the problems there. The community of Wolf Lake contains houses on lots substantially larger than the High Lake and Bear Lake areas with no apparent septic or well problems. Thus there is no established need for the inclusion of the Wolf Lake area in the district.

A review of Chapter 3 of the Feasibility Study shows the focus of the study to be almost entirely upon Bear Lake. Although there is substantial documentation regarding the existing situation at Bear Lake, the only reference to Wolf Lake refers to census data and the following undocumented assertion:

> "These systems include a septic tank and an absorption field. Some homes are <u>thought</u> to have bypassed the absorption field and effluent is discharged to drain tiles which <u>may</u> lead to the lakes. Many of these systems are over 20 years old and have had little or no maintenance activities performed on them. Appendix B includes a letter from the Noble County Health Department describing the type of systems that can be found in the unsewered areas." (Emphasis added).

The letter at Appendix B is directed at situations on Big Lake, High Lake and Bear Lake and does not mention Wolf Lake at all. Clearly the Feasibility Study fails to address the

existing sewerage situation at Wolf Lake. The Feasibility Study in its entirety fails to factually establish any basis for its conclusion regarding the existing and future need for the inclusion of Wolf Lake and surrounding areas in the proposed district.

# ECONOMIC FEASIBILITY

The economics as proposed by the Feasibility Study are also suspect in that it assumes to establish rates with 30% to 45% of the cost of designing and constructing the system through outright grants which need not be repaid, without an analysis of whether or not such funds are presently available, what the priority of this project would be in relation to all other communities seeking similar grants and the eligibility of the proposed district for such grants. Notwithstanding this, the economic feasibility is proposed to be determined without including the alternative of a 100% user financed system; which roughly allocating debt service on \$6,100,000 over 35 years at 5.25% over 657 ERC's costs over \$48.00 per ERC per month for a total rate in excess of \$60.00 per month. This is compounded by the fact that the proposed schedule is already several months behind with the attendant cost increases and there are no delays built in for grant and/or loan approvals or for the issuance and sale of bonds, both of which will result in further delays and cost increases.

As with establishing need, the Feasibility Study purports to assume facts and then concludes that the system is economically feasible. This is mere sophistry and not a study performed to establish known existing facts and then base conclusions on those facts. With the ability to assume the facts, it is no problem to come to any conclusion you

desire. As proposed, the petition and the Feasibility Study fail to establish that the proposed project is economically feasible.

## REQUIREMENTS

The petition and Feasibility Study as proposed and presented do not meet various of the requirements of law as are necessary and required for the hearing officer to recommend the formation of the district and therefore, the recommendation should be to deny or modify the proposed district by excluding Wolf Lake and surrounding areas.

First, the petition was not authorized by the Noble Township Board as required by I.C.§13-3-2-5(b). The approval by the Noble Township Board was conditioned upon a number of items, one of which stated:

"We concur with the need for a sewer system for Bear Lake and High Lake and <u>would</u> approve of a sewer system for Wolf Lake if left to the discretion of the property owners affected." Emphasis added.

This is a clear statement that the Noble Township Board did not yet approve the inclusion of Wolf Lake and surrounding area in a Sewer District but only that it would approve the inclusion of Wolf Lake if the property owners so desired. Under this circumstance, no approval has yet been given. Until this defect has been cured, the petition should not even have been heard by the hearing officer and this matter should be resubmitted to the Noble Township Board.

Next, the petition and other relevant facts (the Feasibility Study) must establish the need for the proposed district. I.C. §13-3-2-5(b); I.C. §13-3-2-3(6). As proposed by the petitioners and further outlined by the Feasibility Study, there are insufficient facts developed to establish the need for any sewage treatment district for Wolf Lake. It is based entirely on speculation with no documentation that there are any existing or future sewage disposal problems in Wolf Lake and surrounding areas.

Last, the petition and other relevant facts (the Feasibility Study) must establish the economic feasibility of the proposed district. I.C. §13-3-2-5(c). This proposal is not based upon facts, but is speculative. This is further compounded by failing to consider any facts related to the availability of grants and not including a zero grant alternative. To fairly present the proposal, it should either factually establish that grants will be available or present the highest and lowest costs to be imposed on the property owners and/or users.

Generally speaking, findings of an administrative agency must be based upon facts and those facts must be based upon substantial evidence in the record. They must be based upon more than mere speculation. Evidence of guess, conjecture, surmise, possibility or suspicion is not sufficient to support an administrative decision. As the record presently exists in this proceeding, the facts are few and far between all of the assumptions and guesses. While agencies have great latitude in interpreting the law and the evidence, they are not entitled to rely upon unsubstantiated assertions.

## CONCLUSION

The findings in this matter should be that there is presently insufficient credible evidence in the record to support the granting of the petition at this time and

should recommend that the proposed district be modified by excluding Wolf Lake and

surrounding areas or the petition should be denied.
