RECOMMENDED FINDINGS OF FACT AND RECOMMENDED ORDER OF THE HEARING OFFICER

- 1. On March 20, 1995, the Noble County Commissioners petitioned the Indiana Department of Environmental Management for an Order establishing a Regional Sewage District to be known as the Bear, High, Wolf Lake Regional Sewer District in Noble County.
- 2. Said Petition complies with the provisions of IC 13-3-2-3 (IC 13-26-2 after July 1, 1996).
- 3. A public hearing was held on February 22, 1996, at the Wolf Lake Elementary School, 10 Main Street, Wolf Lake, Indiana.
- 4. Notice of said hearing was given by publication in newspapers of general circulation in Noble County for two (2) consecutive weeks prior to said hearing and by mailing to each eligible entity involved.
- 5. The proposed name of the District is the Bear, High, Wolf Lake Regional Sewer District.
- 6. The initial principal office of the proposed District is temporarily located at 2169 South Lakeshore Drive, Albion, Indiana 46701.

- 7 The sanitary sewage needs of most residents residing within the proposed District are currently being met with on-site septic systems placed on inadequately sized lots and providing insufficient wastewater treatment. A small percentage of homes are currently being served by a collection system with a failing treatment plant.
- 8. Upon formation of such District, it would construct and operate a sanitary sewage system that would collect and treat the sanitary sewage of the residents of such District.
- 9. Such District is needed to permit the construction of a system to collect and dispose of the sanitary sewage of the residents. The current method of sewage collection and disposal through individual septic systems, and by the failed treatment plant with its collection system, presently is creating health problems and will continue to create such problems for the residents of the proposed District.
- 10. The current method of collection and disposal of the sanitary sewage of the residents of such proposed District is affecting and can affect detrimentally the water quality and public health of the area of the proposed District.
- 11. The Noble County Health Department has stated, in a letter dated September 22, 1994, that the contamination of shallow wells has become a concern.
- 12. The proposed District would include part of Noble County, Indiana. The territory to be included within the boundaries lies primarily in Noble Township, County of Noble, State of Indiana, and is more particularly described as follows:

- 13. There is no outstanding indebtedness currently in the proposed District for the purpose of the construction of a sanitary sewer and treatment system.
- 14. The proposed district shall be governed by a Board of Trustees made up of five (5) directors. All directors shall be from the district and shall serve terms of four (4) years. The directors shall be elected by the residents; however, the initial directors shall be selected by the Noble County Board of Commissioners. The geographical representation among the directors shall

be as follows: two (2) directors from each of Bear Lake and High Lake and one (1) from Wolf Lake.

- 15. The initial project being planned for the District includes the construction and operation of a sewage system in Noble County. The estimated construction cost for phase 1 is \$1,200,000. The connection fee is projected to be up to \$2000. The average monthly per household user fee is projected to be between \$35.00 and \$114.00.
- 16. Funding for the project being planned for Noble County is likely to come from a combination of sources which may include the State Revolving Loan Fund, a sale of bonds, the Community Focus Funds Grant, the Rural Economic and Community Development grants and/or loans.
- 17. The anticipated sources of funds to provide for the operating and maintenance costs of the District would be from the monthly fees charged to the users of the sewage works.
- 18. The District would be eligible to apply for Federal and State financial assistance for construction.
- 19. The District appears capable of accomplishing, in an economically feasible manner, the purposes for which it would be formed.
- 20. Many residents expressed concern, at the public hearing and through written comment, about potentially being forced to abandon their individual working septic tank systems and connect, at great personal expense and without proper public health/water pollution needs documentation, to the District's wastewater treatment system.
- 21. The Noble County Commissioners have passed a resolution dated April 15, 1996, in response to the aforementioned concerns of the residents, which can be found attached to these Findings.
- 22. The Noble County Health Department has stated, in a letter dated March 12, 1996, to Jan Henley, Assistant Commissioner of the Office of Water Management, that the on-site septic systems are failing and creating a public health hazard in the Wolf Lake community.

RECOMMENDED ORDER

The Hearing Officer recommends the following:

- 1. That a Sewer District, to be known as the Bear, High, Wolf Lake Regional Sewer District, be organized as an independent political entity of the State of Indiana as a body corporate and political.
- 2. That the purpose to be accomplished by said District is to provide for the collection, treatment, and disposal of sewage inside and outside the district.

3 That the proposed District would include part of Noble County, Indiana. The territory to be included within the boundaries lies primarily in Noble Township, County of Noble, State of Indiana, and is more particularly described as follows:

- 4. That the proposed district shall be governed by a Board of Trustees made up of five (5) directors. All directors shall be from the district and shall serve terms of four (4) years. The directors shall be elected by the residents; however, the initial directors shall be selected by the Noble County Board of Commissioners. The geographical representation among the directors shall be as follows: two (2) directors from each of Bear Lake and High Lake and one (1) from Wolf Lake.
- That the Board of Trustees provide sufficient bond for all officers, trustees or employees who have any power to disburse funds of the District.
- That within nine (9) months from the date of this order, the District shall file with the Commissioner of the Indiana Department of Environmental Management a detailed plan for the construction and operation of the District's facilities.
